**\*\*All food booths, fryers, BBQ's and cooking equipment must have some form of ground covering (ie:tarps or floor boards) to protect concrete/pavement from grease and food stains & left over slick spots.**

**Booth Set-Up:** Set-up will be on Saturday, September 10th, between 8:00 and 10:30a.m. All cars must be clear of the event area by 10:00a.m. All booths are to remain open from 11a.m.-4p.m.

**Booth Teardown / Cleanup:** Teardown and cleanup is from 4-5:15p.m.

**Booth Requirements:** All booths must have a currently tagged 2A FIRE EXTINGUISHER and are required to follow the Fire Department special event regulations listed on their website [www.ci.eureka.ca.gov/depts/fire](http://www.ci.eureka.ca.gov/depts/fire) click the fire prevention link then click special events.

The Fire Department will inspect every booth prior to the festival and issue permits accordingly.

**Booths must also**, obtain and have at WingFest, a Temporary Food Facility Permit. Permits can be purchased at the Humboldt County Department of Environmental Health (HCDEH) by calling 707-445-6215 The food facility permit and insurance waiver **MUST** be obtained one month prior to event or a \$77.77 late fee will be due.
